1 Information We Collect

Currently, the primary purpose of our Site is to provide information about the upcoming Thumo App and to manage a waitlist for prospective users.

1.1 Personal Data

We collect Personal Data that you voluntarily provide to us when you sign up for our waitlist. This includes:

- **Email Address:** We collect your email address to notify you when the app launches, provide updates on our development progress, and invite you to beta testing (if applicable).

1.2 Derivative Data

Our servers may automatically collect information when you access the Site, such as your IP address, browser type, operating system, access times, and the pages you have viewed directly before and after accessing the Site.

2 How We Use Your Information

We use the information we collect about you to:

- Send you newsletters, updates, and launch notifications regarding Thumo App.
- Manage the waitlist queue.
- Monitor and analyze usage and trends to improve your experience with the Site.
- Protect against fraudulent or illegal activity.

3 Disclosure of Your Information

We do not sell, trade, or otherwise transfer your Personally Identifiable Information to outside parties. This does not include trusted third parties who assist us in operating our website, conducting our business, or servicing you (e.g., email marketing platforms), so long as those parties agree to keep this information confidential.

We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others' rights, property, or safety.

4 Security of Your Information

We use administrative, technical, and physical security measures to help protect your personal information. While we have taken reasonable steps to secure the personal information you provide to us, please be aware that despite our efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse.
